L. B. No. 10-162

A BILL FOR AN ACT

To appropriate the sum of \$7,800 from the Revenue Fund of the Kosrae State Treasury to fund public projects in Malem Municipality; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$7,800 is hereby appropriated from the Revenue
2 Fund of the Kosrae State Treasury for the purpose of providing funding for development projects
3 in the Malem Municipality addressed to the Legislature in Miscellaneous Communication No. 8-
4 81 from Mayor of Malem.

5 Section 2. Apportioned. The sum of \$7,800 shall be apportioned for the following
6 projects.

- 7 1) Coastal Erosion (8 barrels of Diesel).....\$2,080.00
- 8 2) Access Road (8 barrels of Diesel).....\$2,080.00
- 9 3) Farm Road (8 barrels of Diesel).....\$2,080.00
- 10 4) Drainage (6 barrels).....\$1,560.00

11 Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,
12 administered and accounted for in accordance with applicable laws. The allottee of the funds
13 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring
14 that these funds, or so much thereof as may be necessary, are used for the purpose for which are
15 appropriated and that no obligations are incurred in excess of the sum appropriated.

16 Section 4. Effective Date. This act shall become law upon approval by the Governor or
17 upon its becoming law without such approval.
