#### A BILL FOR ACT

To appropriate the amount of \$1,000.00 from the Local Revenue Fund of the Kosrae State Treasury in order to provide funding assistance for the 2014 June 6<sup>th</sup> Memorial Day celebrations to be held in the Municipality of Malem; and for other purposes.

#### BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The amount of \$1,000.00 is appropriated from the Local Revenue 2 Fund of the Kosrae State Treasury in order to provide funding assistance for the 2014 June 6<sup>th</sup> 3 Memorial Day celebrations to be held in the Municipality of Malem. 4 Section 2. Allottee. All funds appropriated by this act shall be allotted, managed, 5 administered and accounted for in accordance with applicable laws. The allottee of the funds 6 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring 7 that these funds, or so much thereof as may be necessary, are used for the purpose for which are 8 appropriated and that no obligations are incurred in excess of the sum appropriated. The 9 authority of the allottee to obligate funds appropriated by this act shall lapse on September 30, 10 2014. 11 Section 3. Effective Date. This act shall become law upon approval by the Governor or 12 upon its becoming law without such approval.
