A BILL FOR ACT

To appropriate the sum of \$1,000 from the Revenue Fund of the Kosrae State Treasury for the purpose of providing funding for the July 20th celebration in Utwe Municipality; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

Section 1. Purpose. The sum of \$1,000 is hereby appropriated from the Revenue Fund 1 of the Kosrae State Treasury for the purpose of providing funding for the July 20th celebration in 2 3 Utwe Municipality. Section 2. Allottee. All funds appropriated by this act shall be allotted, managed, 4 administered and accounted for in accordance with applicable laws. The allottee of the funds 5 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring 6 that these funds, or so much thereof as may be necessary, are used for the purpose for which are 7 appropriated and that no obligations are incurred in excess of the sum appropriated. The 8 authority of the allottee to obligate funds appropriated by this act shall lapse on September 30, 9 10 2014. Section 3. Effective Date. This act shall become law upon approval by the Governor or 11 upon its becoming law without such approval. 12
