



A BILL FOR ACT

To appropriate the sum of \$1,500.00 from the Revenue Fund of the Kosrae State Treasury to fund the Charter Commission of Malem Municipal Government; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$1,500.00 is hereby appropriated from the
2 Revenue Fund of the Kosrae State Treasury to fund the work of the Charter Commission of
3 Malem Municipality as addressed in Municipal Government Message No.10-58.

4 Section 2. Apportionment. The sum \$1,500 shall be apportioned for the following
5 projects:

- 6 1) Supplies/Others.....\$1,500.00

7 Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,
8 administered and accounted for in accordance with applicable laws. The allottee of the funds
9 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring
10 that these funds, or so much thereof as may be necessary, are used for the purpose for which are
11 appropriated and that no obligations are incurred in excess of the sum appropriated.

12 Section 4. Effective Date. This act shall become law upon approval by the Governor or
13 upon its becoming law without such approval.
