

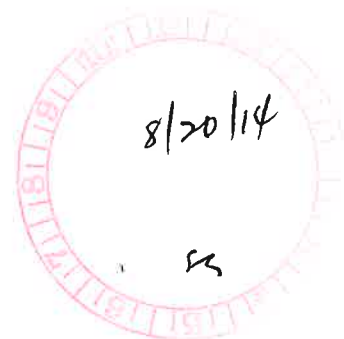

A BILL FOR AN ACT

To further amend State Law 10-91 to appropriate the sum of \$22,365 to supplement the operation of the Executive and Legislative Branch from the Local Revenue Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2014; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Title of State Law No. 10-91 is hereby amended to read as follows:

2 "To appropriate the sum of \$9,738.752 from the Amended Compact Fund; the sum  
3 of \$1,931,994 from the State Revenue Fund; the sum of \$1,017,707 from the United States Grant  
4 Fund; and the sum of \$183,000 from the Foreign Assistance Fund of the Kosrae State Treasury  
5 for the fiscal year ending September 30, 2014, for the purpose of fundirng the operations of all  
6 branches of the Kosrae State Government, its agencies, and various pograms; and for other  
7 purposes."

8 Section 2. Section 1 of State Law No. 10-91 is hereby amended to read as follow:

9 "Section 1. Appropriation. Operation of the Exective. To appropriate the sum of  
10 \$6,057,278 from the Amended Compact Fund; the sum of \$905,575 from the State Revenue  
11 Fund; the sum of \$1,017,707 from the United States Grant Fund; and the sum of \$183,000 from  
12 the Foreign Assistance Fund of the Kosrae State Treasury for the fiscal year ending September  
13 30, 2014."

14 Section 3. Amendment. Section 2 of the State Law No. 10-91 is hereby further amended  
15 to read as follows:

17 “Section 4. Appropriation. Operation of the Legislature. The sum of \$572,506,  
 18 or so much thereof as may be necessary, is appropriated from the State Revenue Fund of the  
 19 Kosrae State Treasury for the operation of the Legislature for the fiscal year ending September  
 20 30, 2014.”

1 Section 5. Amendment. Section 4 of the State Law No. 10-91 is hereby further amended  
2 to read as follows:


