



A BILL FOR AN ACT

To appropriate the sum of \$3,500 from the Revenue Fund of the Kosrae State Treasury to fund the Municipal Governments celebration of the Kosrae State Liberation Day; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$3,500 is hereby appropriated from the Revenue
2 Fund of the Kosrae State Treasury to supplement the celebration of the Kosrae State Liberation
3 Day by the four municipal governments of Kosrae State.

4 Section 2. Apportionment. The sum \$3,500 shall be apportioned as follows:

- 5 1) Malem Municipal Government.....\$750
- 6 2) Lelu Municipal Government.....\$1,000
- 7 3) Tafunsak Municipal Government.....\$1,000
- 8 4) Utwe Municipal Government.....\$750

9 Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,
10 administered and accounted for in accordance with applicable laws. The allottee of the funds
11 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring
12 that these funds, or so much thereof as may be necessary, are used for the purpose for which are
13 appropriated and that no obligations are incurred in excess of the sum appropriated.

14 Section 4. Effective Date. This act shall become law upon approval by the Governor or
15 upon its becoming law without such approval.


