

A BILL FOR AN ACT

To amend Title 13 of the Kosrae State Code, by amending Section 13.557 thereof, to prohibit the sale of cigarette pack containing less than 20 cigarettes and the use of electronic cigarette; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Section 13.557 of Title 13 of the Kosrae State Code, as amended by S.L. No.
2 9-72, is hereby further amended to read as follows:

3 “Section 13.557. Unauthorized sales of tobacco products:

4 (a) Tobacco Products in Usealed Packages. The sale of tobacco
5 products in partial or unsealed packages is prohibited within the State of Kosrae.

6 (b) The sale of cigarette pack or package containing less than 20
7 cigarettes is prohibited within the State of Kosrae.

8 (c) The sale of electronic cigarette is prohibited within the State of
9 Kosrae.

10 Violation of this section is a category one misdemeanor.

11 Section 2. Effective Date. This act shall become law upon approval by the Governor or
12 upon its becoming law without such approval.
