A BILL FOR ACT

To further amend State Law 10-91, as amended by S.L. No. 10-102 and 10-108, by amending the Title, Sections 1, 2, 3, 4, 5, 6, 9, and 10 thereof, to de-appropriate the sum of \$49,580 previously appropriated to fund the fiscal year ending September 30, 2014; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. The Title of State Law No. 10-91 is hereby further amended to read as
2 follows:

3 “To appropriate the sum of \$9,738,752 from the Amended Compact Fund; the
4 sum of \$1,909,629 from the State Revenue Fund; the sum of \$1,017,707 from the United States
5 Grant Fund; and the sum of \$183,000 from the Foreign Assistance Fund of the Kosrae State
6 Treasury for the fiscal year ending September 30, 2014, for the purpose of funding the operations
7 of all branches of the Kosrae State Government, its agencies, and various programs; and for
8 other purposes.”

9 Section 2. Section 1 of State Law No. 10-91 is hereby further amended to read as
10 follows:

11 “Section 1. Appropriation. Operation of the Executive. The sum of \$6,057,278,
12 or so much thereof as may be necessary, is appropriated from the Amended Compact Fund; the
13 sum of \$883,275, or so much thereof as may be necessary, is appropriated from the State
14 Revenue Fund; the sum of \$1,017,707 or so much thereof as may be necessary, is appropriated
15 from the United States Grant Fund; and the sum of \$183,000 or so much thereof as may be
16 necessary, is appropriated from the Foreign Assistance Fund for the operation of the Executive
17 Branch for the fiscal year ending September 30, 2014.”

1 Section 3. Section 2 of State Law No. 10-91 is hereby further amended to read as
 2 follows:

5 “Section 3. Appropriation. Operation of the Legislature. The sum of \$567,441,
 6 or so much thereof as may be necessary, is appropriated from the State Revenue Fund of the
 7 Kosrae State Treasury for the operation of the Legislature for the fiscal year ending September
 8 30, 2014”.

9 Section 5. Section 4 of State Law No. 10-91 is hereby further amended to read as
 10 follows:

11 “Section 4. Apportionment. Operation of the Legislature. The sums appropriated
 12 by Section 3 of this act are apportioned as follows:

 2 sum of \$25,000, or so much thereof as may be necessary, is appropriated from the Foreign
 3 Assistance Fund of the Kosrae State Treasury for the operation of the State Court for the fiscal
 4 year ending September 30, 2014.”

5 Section 7. Section 6 of State Law No. 10-91 is hereby further amended to read as
 6 follows:

7 “Section 6. Apportionment. Operation of the State Court. The sums appropriated
 8 by Section 5 of this act are apportioned as follows:

 17 or so much thereof as may be necessary, is appropriated from the State Revenue Fund; the sum
 18 of \$540,646, or so much thereof as may be necessary, is hereby appropriated from the Amended
 19 Compact Fund; the sum of \$57,068, or so much thereof as may be necessary, is hereby
 20 appropriated from the Foreign Assistance Fund of the Kosrae State Treasury for the operation of

1 certain agencies for the fiscal year ending September 30, 2014.”

2 Section 9. Section 10 of State Law No. 10-91 is hereby further amended to read as
 3 follows:

4 Section 10. Apportionment. Operation of the Certain Agencies. The sums
 5 appropriated by Section 9 of this act are apportioned as follows:
