A BILL FOR AN ACT

To appropriate the sum of \$3,000.00 from the Revenue Fund of the Kosrae State Treasury to fund the 2014 General Election in Malem, Tafunsak, and Utwe Municipalities; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$3,000.00 is hereby appropriated from the
2 Revenue Fund of the Kosrae State Treasury for the purpose of supplementing the funding for the
3 2014 general election in Malem, Tafunsak, and Utwe Municipalities.

4 Section 2. Apportionment. The sum shall be apportioned for the following projects:

8 Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,
9 administered and accounted for in accordance with applicable laws. The allottee of the funds
10 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring
11 that these funds, or so much thereof as may be necessary, are used for the purpose for which are
12 appropriated and that no obligations are incurred in excess of the sum appropriated.

13 Section 4. Effective Date. This act shall become law upon approval by the Governor or
14 upon its becoming law without such approval.
