

A BILL FOR AN ACT

To appropriate the sum of \$10,000.00 from the Revenue Fund of the Kosrae State Treasury for the purpose of providing an additional State capital contribution to the Pacific Island Development Bank (PIDB); and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Appropriation. The sum of \$10,000.00 is hereby appropriated from the  
2 Revenue Fund of the Kosrae State Treasury for the purpose of providing an additional State  
3 capital contribution to the Pacific Island Development Bank (PIDB).

4           Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,  
5 administered and accounted for in accordance with applicable laws. The allottee of the funds  
6 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring  
7 that these funds, or so much thereof as may be necessary, are used for the purpose for which are  
8 appropriated and that no obligations are incurred in excess of the sum appropriated.

9           Section 3. Effective Date. This act shall become law upon approval by the Governor or  
10 upon its becoming law without such approval.
