A BILL FOR AN ACT

To further amend Title 7, Section 7.1206 of the Kosrae State Code as added by State Law No. 5-38 and amended by State Law No. 9-15, thereof, to modify the composition of the Kosrae Utility Authority Board; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

Section 1. <u>Purpose</u>. The purpose of this act is to modify the Kosrae Utility Authority

2 Board ex-officio, not to be strictly the Director of the Department of Transportation and

Infrastructure, rather a person appointed by the Governor.

Section 2. Amendment. Title 7, Section 7.1206 of the Kosrae State Code as added by

State Law No. 5-38 and amended by State Law No. 9-15, thereof, is hereby amended to read as

"Section 7.1206. Composition of the Board; term.

8 The Bureau is governed by a Board of five Directors. The Board is composed of four

Directors appointed by the Governor with the advice and consent of the Legislature, and, ex-

officio, appointed by the Governor. An appointed Director serves for a term of four years,

subject to reappointment, and until his successor has been appointed and qualifies. Initially, the

12 Governor appoints two Directors to two year terms and two Directors to four year terms. A

vacancy is filled for the remainder of the term for the vacated position. The General Manager

serves pursuant to the provisions of Section 7.1209."

Section 3. Effective Date. This act shall become law upon approval by the Governor or

upon its becoming law without such approval.
