A BILL FOR AN ACT

To appropriate the sum of \$1,000.00 from the Revenue Fund of the Kosrae State Treasury to provide financial contribution and assistance for Kosrae State's participation in the FSM Juniors Tennis Qualifying Event scheduled to be held in Pohnpei from December 19-22, 2011; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$1,000.00 is hereby appropriated from the
2 Revenue Fund of the Kosrae State Treasury to provide financial contribution and assistance for
3 Kosrae State's participation in the FSM Juniors Tennis Qualifying Event scheduled to be held in
4 Pohnpei from December 19-22, 2011.

5 Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,
6 administered and accounted for in accordance with applicable laws. The allottee of the fund
7 appropriated by this act shall be the Governor of the State of Kosrae. The allottee shall be
8 responsible for ensuring that these funds, or so much thereof as may be necessary, are used
9 solely for the purpose specified in this act and that no obligations are incurred in excess of the
10 sum appropriated.

11 Section 3. Effective Date. This act takes effect upon the approval of the Governor or
12 upon its becoming law without such approval.
