A BILL FOR AN ACT

To appropriate the sum of \$2,682 from the Local Revenue Fund of the Kosrae State Treasury for the purpose of funding the Micronesian Chief Executive Summit; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

Section 1. <u>Appropriation.</u> The sum of \$2,682 is hereby appropriated from the Local Revenue Fund of the Kosrae State Treasury to defray the costs of hosting the Micronesian Chief Executive Summit to be held during the week of December 5-10, 2011.

Section 2. <u>Allottee.</u> All funds appropriated by this act shall be allotted, managed, administered and accounted for in accordance with applicable laws. The allottee of the fund

administered and accounted for in accordance with applicable laws. The allottee of the fund appropriated by this act shall be the Governor of the State of Kosrae. The allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act and that no obligations are incurred in excess of the sum appropriated.

Section 3. <u>Effective Date</u>. This act takes effect upon the approval of the Governor or upon its becoming law without such approval.
