A BILL FOR AN ACT

To appropriate the sum of \$10,000 from the Revenue Fund of the Kosrae State Treasury to provide funding for the maintenance of road segment 2b of the Kosrae circumferential road; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$10,000 is hereby appropriated from the Revenue
2 Fund of the Kosrae State Treasury for the purpose of funding the maintenance of road segment
3 2b of the Kosrae circumferential road.

4 Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,
5 administered and accounted for in accordance with applicable laws. The allottee of the fund
6 appropriated by this act shall be the Governor of the State of Kosrae. The allottee shall be
7 responsible for ensuring that these funds, or so much thereof as may be necessary, are used
8 solely for the purpose specified in this act and that no obligations are incurred in excess of the
9 sum appropriated. The authority of the allottee to obligate funds appropriated by this act shall
10 lapse on September 30, 2012.

11 Section 3. Effective Date. This act takes effect upon the approval of the Governor or
12 upon its becoming law without such approval.
