#### A BILL FOR AN ACT

To appropriate the sum of \$15,000 from the Revenue Fund of the Kosrae State Treasury to fund the operation of the Kosrae Office of Micronesian Legal Services Corporation; and for other purposes.

#### BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$15,000 is hereby appropriated from the Revenue 2 Fund of the Kosrae State Treasury to fund the operation of the Kosrae Office of Micronesian 3 Legal Services Corporation. 4 Section 2. All funds appropriated by this act shall be allotted, managed, 5 administered and accounted for in accordance with applicable laws. The allottee of the fund 6 appropriated by this act shall be the Governor of the State of Kosrae. The allottee shall be 7 responsible for ensuring that these funds, or so much thereof as may be necessary, are used 8 solely for the purpose specified in this act and that no obligations are incurred in excess of the 9 sum appropriated. 10 Section 3. Effective Date. This act takes effect upon the approval of the Governor or 11 upon its becoming law without such approval.
