A BILL FOR AN ACT

To appropriate the sum of \$5,647.19 from the Local Revenue Fund of the Kosrae State Treasury to provide funding for the operation of the USDA Rural Development Office; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

Section 1. Appropriation. The sum of \$5,647.19 is hereby appropriated from the Local Revenue Fund of the Kosrae State Treasury for the purpose of funding the salaries of the gratuitous employees working with USDA Rural Development Office in the State of Kosrae. for the second quarter of the fiscal year 2012.

Section 2. Allottee. All funds appropriated by this act shall be allotted managed.

Section 2. All funds appropriated by this act shall be allotted, managed, administered and accounted for in accordance with applicable laws. The allottee of the fund appropriated by this act shall be the Governor of the State of Kosrae. The allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act and that no obligations are incurred in excess of the sum appropriated.

Section 3. <u>Effective Date</u>. This act takes effect upon the approval of the Governor or upon its becoming law without such approval.
