



A BILL FOR AN ACT

To amend State Law 9-66, to further appropriate the additional sum of \$7,077.98 from the Revenue Fund of the Kosrae State Treasury to supplement the operation of the USDA Rural Development; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Purpose. The purpose of this act is to appropriate the additional sum of  
2     \$7,077.98 from the Revenue Fund of the Kosrae State Treasury to fund the remaining quarters  
3     of operation for the USDA Rural Development for fiscal year 2011.

4           Section 2. Apportionment. The amount of this act shall be apportioned as follows:

5                     "Personnel                                     \$31,152.98

6           Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,  
7     administered and accounted for in accordance with applicable laws. The allottee of the fund  
8     appropriated by this act shall be the Governor of the State of Kosrae who shall be responsible  
9     for ensuring that these funds, or so much thereof as may be necessary, are used solely for the  
10    purpose specified in this act and that no obligations are incurred in excess of the sum  
11    appropriated. This appropriation shall be lapse no later than September 30, 2011.

12          Section 4. Effective Date. This act takes effect upon the approval of the Governor or  
13    upon its becoming law without such approval.
