#### A BILL FOR AN ACT

To appropriate funds from the general revenue fund of the Kosrae State Treasury for 'representation funds" for the 10<sup>th</sup> Kosrae State Legislature, the Office of the Governor, and the Kosrae State Court for the 2012 fiscal year; and for other purposes.

### BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

- Section 1. <u>Purpose</u>. The purpose of this act is to appropriate \$17,000.00 from the general revenue fund for the representation funds for the Governor, Lt. Governor, members of the Kosrae State Legislature, and the Chief Justice for the 2012 fiscal year ending September 30, 2012.
- Section 2. <u>Appropriation. Operation of the Legislature</u>. The sum of \$14,000.00 is appropriated from the general revenue fund of the Kosrae State Treasury for representation funds for the 10<sup>th</sup> Kosrae State Legislature.
- Section 3. <u>Appropriation. Operation of the Executive</u>. The sum of \$2,000.00 is appropriated from the general revenue fund of the Kosrae State Treasury for representation funds for the Governor and Lt. Governor.
- Section 4. <u>Appropriation. Operation of the State Court.</u> The sum of \$1,000.00 is appropriated from the general revenue fund of the Kosrae State Treasury for representation funds for the Chief Justice.
  - Section 5. Allottee. All funds appropriated by this act shall be allotted, managed, administered and accounted for in accordance with applicable laws. The office of funds appropriated and apportioned under sections (2), (3) and (4) the Governor, the Speaker and the Chief Justice respectively. The allottees shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act. The

1	authority of the allottee to obligate funds appropriated by this act shall lapse as of September 30
2	2012.
3	Section 6. Effective Date. This act takes effect upon the approval of the Governor or
4	upon its becoming law without such approval.
