#### A BILL FOR AN ACT

To amend State Law No. 10-14, at Sections 1 and 2 (1), (16), and (17), and Sections 3 and Section 4(c) to supplement the operation of the Governor's Office, Attorney General's Office, the Department of Administration and Finance, and the Operation of the Legislature; and for other purposes.

#### BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

- Section 1. <u>Purpose</u>. The purpose of this act is to supplement the operation of the
- 2 Governor's Office, Attorney General's Office, the Department of Administration and Finance,
- 3 and the Operation of the Legislature by providing additional \$55,500 from the Local Revenue for
- 4 the fiscal year ending September 30, 2012.
- 5 Section 2. Amendment. Section 1 and 2 of the Kosrae State Law No. 10-14 are hereby
- 6 amended to read as follows:
- 7 "Section 1. Appropriation. Operation of the Executive. The sum of \$4,532,574, or so
- 8 much thereof as may be necessary, is appropriated from the Amended Compact Fund; the sum of
- 9 \$900,606, or so much thereof as may be necessary, is appropriated from the State Revenue Fund;
- the sum of \$2,369,264, or so much thereof as may be necessary, is appropriated from the United
- 11 States Grant Fund; and the sum of \$25,000, or so much thereof as may be necessary, is
- 12 appropriated from the Foreign Assistance Fund for the operation of the Executive Branch for the
- 13 fiscal year ending September 30, 2012.
- 14 Section 2. Apportionment. Operation of the Executive. The sums appropriated by
- 15 Section 1 of this act are apportioned as follows:
