A BILL FOR AN ACT

To appropriate the sum of \$10,000 from the Local Revenue Fund of the Kosrae State Treasury to provide funding to subsidize municipal projects and programs; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$10,000 is hereby appropriated from the Local
2 Revenue Fund of the Kosrae State Treasury to providing funding to all municipalities in order to
3 subsidize municipal projects and programs. The appropriated sum will be allocated as follows:
4 \$2000 for Utwe municipality, \$2000 for Malem, \$3000 for Tafunsak and \$3000 for Lelu,
5 respectively.

6 Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,
7 administered and accounted for in accordance with applicable laws. The allottee of the funds
8 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring
9 that these funds, or so much thereof as may be necessary, are used for the purpose for which are
10 appropriated and that no obligations are incurred in excess of the sum appropriated.

11 Section 3. Effective Date. This act takes effect upon the approval of the Governor or
12 upon its becoming law without such approval.
