A BILL FOR AN ACT

To appropriate the sum of \$505,000 from the Foreign Assistance Fund of the Kosrae State Treasury for the purpose of funding certain projects for the Kosrae Island Resource Management Authority in the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

- Section 1. <u>Appropriation</u>. The sum of \$505,000 is hereby appropriated from the Foreign
- 2 Assistance Fund of the Kosrae State Treasury for the purpose of funding certain projects for the
- 3 Kosrae Island Resource Management Authority in the State of Kosrae.
- Section 2. Apportionment. The sums appropriated by Section 1 of this act are
- 5 apportioned as follows:
- 6 YELA Conservation Project \$500,000
- 7 2. Kosrae Legacy Project Administration Grant \$5,000
- 8 Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,
- 9 administered and accounted for in accordance with applicable laws. The allottee of the funds
- appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring
- that these funds, or so much thereof as may be necessary, are used for the purpose for which are
- appropriated and that no obligations are incurred in excess of the sum appropriated.
- Section 4. <u>Effective Date</u>. This act takes effect upon the approval of the Governor or
- 14 upon its becoming law without such approval.
