A BILL FOR AN ACT

To amend State Law No. 9-143, at Section 4(d), to supplement the operation of the Legislature; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Purpose. The purpose of this act is to supplement the operation of the  
2   Legislature by providing additional \$10,000 from the Local Revenue Fund for the  
3   Legislature’s utilities for the fiscal year ending September 30, 2011.

4           Section 2. Amending. Section 4(d) of State Law 9-143 is amended to read as follows:

5	“(a)	Personnel	-0-	435,383	-0-	-0-
6	(b)	Travel	-0-	20,000	-0-	-0-
7	(c)	Contractual	10,000	15,200	-0-	-0-
8	(d)	Others	-0-	62,750	-0-	-0-
9	(e)	Fixed Assets	-0-	10,000	-0-	-0-“


10           Section 3. Effective Date. This act takes effect upon the approval of the Governor or  
11   upon its becoming law without such approval.
