#### A BILL FOR AN ACT

To appropriate the sum of \$2,000 from the Revenue Fund of the Kosrae State Treasury to provide funding for Kosrae's High School basketball team to the Varsity Basketball Tournament to be held in Pohnpei on December 2012; and for other purposes.

#### BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

Section 1. <u>Appropriation</u>. The sum of \$2,000 is herby appropriated from the Revenue

Fund of the Kosrae State Treasury to provide funding for Kosrae's High School basketball team

3 to the Varsity Basketball Tournament to be held in Pohnpei on December 2012.

Section 2. Allotment. All funds appropriated by this act shall be allotted, manified, administered and accounted for in accordance with applicable laws. The allottee of the funds appropriated shall be the Governor of the State of Kosrae. The allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act and that no obligations are incurred in excess of the sum appropriated.

Section 3. <u>Effective Date</u>. This act takes effect upon the approval of the Governor or upon its becoming law without such approval.
