### A BILL FOR AN ACT

To appropriate the sum of \$37,300 from the Local Revenue Fund of the Kosrae State Treasury for the purpose of funding the MPC Loan Repayment with the FSM Development Bank in the State of Kosrae; and for other purposes.

## BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$37,300 is hereby appropriated from the Local 2 Revenue Fund of the Kosrae State Treasury for the purpose of funding the MPC Loan 3 Repayment with the FSM Development Bank in the State of Kosrae. 4 Section 2. Allotment. All funds appropriated by this act shall be allotted, managed, 5 administered and accounted for in accordance with applicable laws. The allottee of the funds appropriated shall be the Governor of the State of Kosrae. The allottee shall be responsible for 6 7 ensuring that these funds, or so much thereof as may be necessary, are used solely for the 8 purpose specified in this act and that no obligations are incurred in excess of the sum 9 appropriated. 10 Section 3. Effective Date. This act takes effect upon the approval of the Governor or 11 upon it becoming law without such approval.
