



A BILL FOR AN ACT

To amend Title 18 of the Kosrae State Code, by amending Chapter 6 thereof, as amended by SL Nos. 6-132, 6-160, 7-40, 7-47, 7-184, 7-210 and 8-117, to add a new Section 18.609 for the purpose of regulating transportation expenses of noncitizen employees of Kosrae State; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Title 18 of the Kosrae State Code, as amended by SL. Nos. 6-132, 6-160, 7-
2 40, 7-47, 7-184, 7-210 and 8-117, is hereby further amended by amending Chapter 6 thereof for
3 the purpose of exacting a new Section 18.609 to read as follows:

4 “Section 18.609. Transportation expenses of noncitizen employees:

5 (1) Defintion. As used in this section:

6 (a) “dependent” is a spouse or a child under the age of 18 of the
7 employee.

8 (b) “employee” means a noncitizen employee hired from outside
9 of Kosrae.

10 (c) “interim employment period” means the employment period
11 occuring between the time of hiring and the time of final termination of employment.

12 (d) “place of hire” means the place where the employee was
13 hired from.

14 (e) “termination of employment” means the actual end of
15 employment seviles and not merely the end of employment contract, which may be extended for
16 another period of employment.

1 (2) Payment of transportation expenses allowed. The State shall pay the
2 transportation costs of a newly hired noncitizen employee and not more than one dependent from
3 his or her place of hire to Kosrae and their return transportation after the termination of
4 employment of the employee.


5 (3) Existing contracts. The State shall continue to be obligated to pay
6 transportation expenses of noncitizen employees pursuant to the employment contracts entered
7 into by such employees and the State before the effective date of this act. All employment
8 contracts of employees entered into after the effective date of this act shall conform to the
9 provisions of Subsection (2) of this section.

10 Section 2. Effective Date. This act shall become law upon approval by Governor or
11 upon its becoming law without such approval.


