





A BILL FOR AN ACT

To appropriate the sum of \$14,150.40 from the Foreign Assistance Fund of the Kosrae State Treasury to fund the purchase of a glass bottle pulverizer; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$14,150.40 is hereby appropriated from the
2 Foreign Assistance Fund of the Kosrae State Treasury for the purpose of funding the purchase
3 and installation of a glass bottle pulverizer.

4 Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,
5 administered and accounted for in accordance with applicable laws. The allottee of the fund
6 appropriated by this act shall be the Governor of the State of Kosrae. The allottee shall be
7 responsible for ensuring that these funds, or so much thereof as may be necessary, are used for
8 the purpose specified in this act and that no obligations are incurred in excess of the sum
9 appropriated. The authority of the allottee to obligate funds appropriated by this act shall lapse
10 on December 30, 2013.

11 Section 3. Effective Date. This act shall become law upon approval by Governor or
12 upon its becoming law without such approval.


