

A BILL FOR AN ACT

To amend SL. No. 10-46 at Sections 1, 2, 11 and 12 thereof to reduce the amount earmarked for the Department of Administration and Finance, Retirement Pension Program and Stabilization Loan Repayment Program; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is to reduce amount earmarked for certain
2 department and programs in the State of Kosrae.

3 Section 2. Amendment. Sections 1, 2, 11 and 12 of State Law No. 10-46 is hereby
4 amended to read as follows:

5 “Section 1. Appropriation. Operation of the Executive. The sum of \$5,889,421, or so
6 much thereof as may be necessary, is appropriated from the Amended Compact Fund; the sum of
7 \$894,616, or so much thereof as may be necessary, is appropriated from the State Revenue Fund;
8 the sum of \$881,352 or so much thereof as may be necessary, is appropriated from the United
9 States Grant Fund; and the sum of \$25,000, or so much thereof as may be necessary, is
10 appropriated from the Foreign Assistance Fund for the operation of the Executive Branch for the
11 fiscal year ending September 30, 2013.

12 Section 2. Apportionment. Operation of the Executive. The sums appropriated by
13 Section 1 of this act are apportioned as follows:

5 Section 11. Appropriation. The sum of \$3,536,828, or so much thereof as may be
6 necessary, is appropriated from the Amended Compact Fund; the sum of \$2,467 is appropriated
7 from the Revenue Fund; and the sum of \$133,000 is appropriated from the Foreign Assistance
8 Fund of the Kosrae State Treasury for the purpose of funding certain Governmental programs,
9 grants, and contributions for the fiscal year ending September 30, 2013.


10 Section 12. Apportionment. The sums appropriated by Section 11 of this act is
11 apportioned as follows:

15 3. Effective Date. This act shall become effective upon the approval of the Governor or
