

A BILL FOR AN ACT

To appropriate the sum of \$2,400.00 from the Local Revenue Fund of the Kosrae State Treasury for the purpose of contributing to the funding of the Kosrae Junior Tennis fundraising; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$2,400.00 from the Local Revenue Fund of the
2 Kosrae State Treasury for the purpose of contributing to the funding of the Kosrae Junior Tennis
3 fundraising for their participation in the North Pacific Qualifying Junior Tennis Tournament to
4 be held in Saipan from June 12, 2013 to June 16, 2013.

5 Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,
6 administered and accounted for in accordance with applicable laws. The allottee of the fund
7 appropriated by this act shall be the Governor of the State of Kosrae. The allottee shall be
8 responsible for ensuring that these funds, or so much thereof as may be necessary, are used
9 solely for the purpose specified in this act and that no obligations are incurred in excess of the
10 sum appropriated. The authority of the allottee to obligate funds appropriated by this act shall
11 lapse on September 30, 2013.

12 Section 3. Effective Date. This act shall become law upon approval by Governor or
13 upon its becoming law without such approval.


