A BILL FOR AN ACT

To appropriate the sum of \$7,800 from the Revenue Fund of the Kosrae State Treasury to provide funding for the maintenance of Road Sections-1, 2, 2(a), 2(b) and 5 in the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

Section 1. <u>Appropriation.</u> The sum of \$7,800 is hereby approriated from the Revenue

Fund of the Kosrae State Treasury for the purpose of providing funding for the maintenance of

Road Sections-1, 2, 2(a), 2(b) and 5 in the State of Kosrae.

Section 2. <u>Allottee.</u> All funds appropriated by this act shall be allotted, managed,

administered and accounted for in accordance with applicable laws. The allottee of the fund

administered and accounted for in accordance with applicable laws. The allottee of the fund appropriated by this act shall be the Governor of the State of Kosrae. The allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used for the purpose specified in this act and that no obligations are incurred in excess of the sum appropriated.

Section 3. <u>Effective Date</u>. This act shall become law upon approval by Governor or upon its becoming law without such approval.
