





A BILL FOR AN ACT

To amend Title 12 of the Kosrae State Code, by amending Section 12.1604 thereof, to prohibit smoking in private vehicles when a passenger is a minor; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Amendment. Section 12.1604 of Title 12 of the Kosrae State Code is hereby
2 amended to as follows:

3 Section 12.1604. Prohibition of Smoking in Places of Employment.

4 (1) Smoking shall be prohibited in all enclosed places of employment
5 without exception. This includes common work areas, auditoriums, classrooms, conference and
6 meeting rooms, private offices, elevators, hallways, medical facilities, cafeterias, employee
7 lounges, stairs, restrooms, vehicles, and all other enclosed facilities.

8 (2) This prohibition on smoking shall be communicated to all existing
9 employees by the effective date of this Act and to all prospective employees upon their
10 application for employment.


11 (3) Smoking in private vehicle is prohibited when any passenger is a
12 minor.”

13 Section 2. Effective Date. This act takes effect upon the approval of the Governor or
14 upon its becoming law without such approval.
