





A BILL FOR AN ACT

To further amend State Law No. 9-66 as amended by State Law 10-3, to appropriate additional sum of \$465.31 from the Revenue Fund of the Kosrae State Treasury to supplement the operation of the USDA Rural Development; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Purpose. The purpose of this act is to appropriate additional sum of \$465.31  
2           from the Revenue Fund of the Kosrae State Treasury to fund the remaining quarter of operation  
3           for the USDA Rural Development for fiscal year 2011.

4           Section 2. Apportionment. The amount of this act shall be apportioned as follows:

5           "Personnel	\$31,518.29"
------------------------	--------------

6           Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,  
7           administered and accounted for in accordance with applicable laws. The allottee of the fund  
8           appropriated by this act shall be the Governor of the State of Kosrae. The allottee shall be  
9           responsible for ensuring that these funds, or so much thereof as may be necessary, are used  
10           solely for the purpose specified in this act and that no obligations are incurred in excess of the  
11           sum appropriated. The authority of the allottee to obligate funds appropriated by this act shall  
12           lapse on September 30, 2011.

13           Section 4. Effective Date. This act takes effect upon the approval of the Governor or  
14           upon its becoming law without such approval.


