A BILL FOR AN ACT

To appropriate the sum of \$6,800 from the Revenue Fund of the Kosrae State Treasury for the purpose of funding the court judgment against Kosrae State Government and its Department of Education to Mr. Eterny Edwin and Mr. Alikxa Sigrah in the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$6,800 from the Revenue Fund of the Kosrae
2 State Treasury for the purpose of funding the court judgment against Kosrae State Government
3 and its Department of Education to Mr. Eterny Edwin and Mr. Alikxa Sigrah in the State of
4 Kosrae.

5 Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,
6 administered and accounted for in accordance with applicable laws. The allottee of the funds
7 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for
8 ensuring that these funds, or so much thereof as may be necessary, are used for the purpose
9 for which are appropriated and that no obligations are incurred in excess of the sum
10 appropriated.

11 Section 3. Effective Date. This act shall become law upon approval by the Governor
12 or upon its becoming law without such approval.


