

A BILL FOR ACT

To appropriate the amount of \$1,000.00 from the Local Revenue Fund of the Kosrae State Treasury for the purpose of contributing to the Kosrae Junior Tennis fundraising and as a token of support for their participation in the FSM Junior Tennis Championship Tournament to be held in Pohnpei from December 30, 2013 to January 2, 2014; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. To appropriate \$1,000.00 from the Local Revenue Fund of the
2 Kosrae State Treasury for the purpose of contributing to the Kosrae Junior Tennis fundraising
3 and as a token of support for their participation in the FSM Junior Tennis Championship
4 Tournament to be held in Pohnpei from December 30, 2013 to January 2, 2014.

5 Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,
6 administered and accounted for in accordance with applicable laws. The allottee of the funds
7 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring
8 that these funds, or so much thereof as may be necessary, are used for the purpose for which are
9 appropriated and that no obligations are incurred in excess of the sum appropriated. The
10 authority of the allottee to obligate funds appropriated by this act shall lapse on September 30,
11 2014.

12 Section 3. Effective Date. This act shall become law upon approval by the Governor or
13 upon its becoming law without such approval.
