





A BILL FOR ACT

To appropriate the amount of \$56,925 from the Foreign Assistance Fund of the Kosrae State Treasury for the purpose of funding certain health projects and programs in the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Appropriation. The sum of \$56,925 is hereby appropriated from the Foreign  
2 Assistance Fund of the Kosrae State Treasury for the purpose of funding certain health projects  
3 and programs in the State of Kosrae.

4           Section 2. Apportionment. The sum appropriated by Section 1 of this act is hereby  
5 apportioned as follows:

- 6           1.     Biking Against NCD-.....\$10,000
- 7           2.     Mitigating NCD Crisis-.....\$46,925

8           Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,  
9 administered and accounted for in accordance with applicable laws. The allottee of the funds  
10 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring  
11 that these funds, or so much thereof as may be necessary, are used for the purpose for which are  
12 appropriated and that no obligations are incurred in excess of the sum appropriated.

13           Section 4. Effective Date. This act shall become law upon approval by the Governor or  
14 upon its becoming law without such approval.


