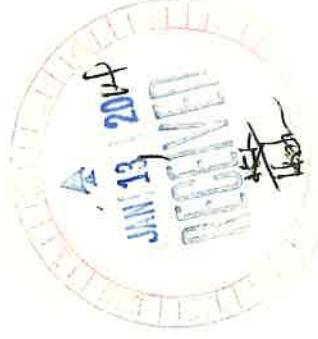



A BILL FOR AN ACT

To amend Title 13 of the Kosrae State Code by adding new Section 13.558 to prohibit the advertisement of tobacco products; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this Act is to prohibit the advertisement of tobacco
2 products or harmful products to the general public.

3 Section 2. Amendment. Title 13 of the Kosrae State Code is hereby amended by adding
4 a new Section 13.558 to read as follows:

5 “Section 13.558. Advertising of tobacco products.

6 (1) No manufacturer, retailer, distributor of tobacco products or other
7 person shall advertise or promote by billboard, radio, television, public broadcast, handout,
8 device or otherwise for commercial purposes;

9 (a) Cigarettes, cigars, pipe tobacco, chewing tobacco, snuff or
10 other products;

11 (2) Notwithstanding the prohibitions of subsection (1) of this Section,
12 nothing herein shall prohibit a commercial vendor from advertising prices of legal products by
13 hand-drafted signs, provided, however, that such signs are inside of the vendor’s premises and
14 not visible to the public from outside of the vendor’s premises.

15 (3) Any person who violates the provisions of this Section shall be guilty
16 of a category two misdemeanor.”

17 Section 3. Effective Date. This act shall become law upon approval by the Governor
18 or upon its becoming law without such approval.


