

A BILL FOR AN ACT

To further amend title of State Law No. 10-91 and Section 1, 2 and 9, and 10 thereof, to appropriate the sum of \$25,084 from the State Revenue Fund to supplement the operation of the Division of Land Administration under the Department of Resources and Economic Affairs and the Parole Board for the fiscal year ending September 30, 2014; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. The title of State Law No. 10-91 is hereby amended to read as follows:

2 “To appropriate the sum of \$9,738,752 from the Amended Compact Fund; the
3 sum of \$1,959,206 from the State Revenue Fund; the sum of \$1,017,707 from the United States
4 Grant Fund; and the sum of \$183,000 from the Foreign Assistance Fund of the Kosrae State
5 Treasury for the fiscal year ending September 30, 2014, for the purpose of funding the operations
6 of all branches of the Kosrae State Government, its agencies, and various programs; and for
7 other purposes.”

8 Section 2. Amendment. Section 1 of the State Law No. 10-91 is hereby further amended
9 to read as follows:

10 “Section 1. Appropriation. Operation of the Executive. The sum of \$6,087,278, or so
11 much thereof as may be necessary, is appropriated from the Amended Compact Fund; the sum of
12 \$903,913, or so much thereof as may be necessary, is appropriated from the State Revenue Fund; the
13 sum of \$960,639 or so much thereof as may be necessary, is appropriated from the United States Grant
14 Fund; and the sum of \$25,000, or so much thereof as may be necessary, is appropriated from the
15 Foreign Assistance Fund for the operation of the Executive Branch for the fiscal year ending
16 September 30, 2014.”

1 Section 3. Section 2(18) of the State Law No. 10-91 is hereby further amended to read as
2 follows:

3 “Section 2. Apportionment. Operation of the Executive. The sums appropriated
4 by Section 1 of this act are apportioned as follows:

13 Section 4. Section 9 of the State Law No. 10-91 is hereby further amended to read as
14 follows:

15 “Section 9. Appropriation. Operation of Certain Agencies. The sum of \$92,180,
16 or so much thereof as may be necessary, is appropriated from the Revenue Fund; the sum of
17 \$540,646, or so much thereof as may be necessary, is hereby appropriated from the Amended
18 Compact Fund; the sum of \$57,068 is hereby appropriated from the United States Grant Fund of
19 the Kosrae State Treasury for the operation of certain agencies for the fiscal year ending
20 September 30, 2014.”

1 Section 5. Section 10(3) of the State Law No. 10-91 is hereby further amended to read as
2 follows:

3 "Section 10. Apportionment. Operation of the Certain Agencies. The sums
4 appropriated by Section 9 of this act are apportioned as follows:


