A BILL FOR AN ACT

To amend Title 5, by amending Section 5.501 thereof, to improve the salary of cabinet members providing professional services; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this Act is to improve the salary of cabinet members
2 providing professional services.

3 Section 2. Amendment. Section 5.501 of Title 5 of the Kosrae State Code is hereby
4 amended to read as follows:

5 “Section 5.501. Salary of Governor, Lieutenant Governor and directors. The
6 annual salary of the Governor is twenty-two thousand eight hundred dollars (\$22,800.00). The
7 annual salary of the Lieutenant Governor is nineteen thousand nine hundred fifty dollars
8 (\$19,950.00). Unless otherwise provided by contract for the employment of a professional
9 providing professional services, the annual salary of a director of a department is seventeen
10 thousand one hundred dollars (\$17,100.00) and a director has no leave benefits. A director
11 makes himself available at all times for the performance of his duties.”

12 Section 3. Effective Date. This act shall become law upon approval by the Governor or
13 upon its becoming law without such approval.
