





A BILL FOR ACT

To appropriate the sum of \$1,000 from the Revenue Fund of the Kosrae State Treasury for the purpose of providing funding for the July 20th celebration in Utwe Municipality; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The sum of \$1,000 is hereby appropriated from the Revenue Fund
2 of the Kosrae State Treasury for the purpose of providing funding for the July 20th celebration in
3 Utwe Municipality.

4 Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,
5 administered and accounted for in accordance with applicable laws. The allottee of the funds
6 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring
7 that these funds, or so much thereof as may be necessary, are used for the purpose for which are
8 appropriated and that no obligations are incurred in excess of the sum appropriated. The
9 authority of the allottee to obligate funds appropriated by this act shall lapse on September 30,
10 2014.

11 Section 3. Effective Date. This act shall become law upon approval by the Governor or
12 upon its becoming law without such approval.
