



A BILL FOR ACT

To appropriate the sum of \$10,000 from the Local Revenue Fund of the Kosrae State Treasury for the purpose of funding the third and fourth quarters of the out-of-court settlement between the Kosrae State Government, its Department of Health Services and Ms. Betsyrose Mongkeya as per the medical case file against the Department of Health Services in the State of Kosrae, and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$10,000 is here by appropriated from the Local
2 Revenue Fund of the Kosrae State Treasury for the purpose of funding the third and fourth
3 quarters of the out-of-court settlement between the Kosrae State Government, its Department of
4 Health Services and Ms. Betsyrose Mongkeya as per the medical case file against the
5 Department of Health Services in the State of Kosrae.

6 Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,
7 administered and accounted for in accordance with applicable laws. The allottee of the funds
8 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring
9 that these funds, or so much thereof as may be necessary, are used for the purpose for which are
10 appropriated and that no obligations are incurred in excess of the sum appropriated.

11 Section 3. Effective Date. This act shall become law upon approval by the Governor or
12 upon its becoming law without such approval.


