A BILL FOR AN ACT

To amend Title 13 of the Kosrae State Code by amending Section 13.703(17)(e) thereof, to lengthen the applicable distance from which a motor vehiclee may park within the placement of a fire hydrant or an area so designated; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Amendment. Section 13.703(17)(e) of Title 13 of the Kosrae State Code is  
2 hereby amended to read as follows:

3                   “Section 13.703. Violating rules of the road.

4                           (17) Stopping or parking a vehicle, whether attended or unattended, in any  
5 of the following places:


6                                   (e) within fifty feet of a fire hydrant or an area so designated.”


7           Section 2. Effective Date. This act shall become law upon approval by the Governor or  
8 upon its becoming law without such approval.
