



A BILL FOR AN ACT

To appropriate the sum of \$10,550.00 from the Revenue Fund of the Kosrae State Treasury for the purpose of providing funding assistance for the 2014 Women's Conference; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Appropriation. The sum of \$10,550.00 is hereby appropriated from the  
2 Revenue Fund of the Kosrae State Treasury for the purpose of providing funding 6 participants  
3 from Kosrae to attend the 2014 Women's Conference to be held in Pohnpei on October 20 – 24,  
4 2014 as requested in Micellaneous Communication No. 10-285.

5           Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,  
6 administered and accounted for in accordance with applicable laws. The allottee of the funds  
7 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring  
8 that these funds, or so much thereof as may be necessary, are used for the purpose for which are  
9 appropriated and that no obligations are incurred in excess of the sum appropriated. The  
10 authority of the allottee to obligate funds appropriated by this act shall lapse on September 3-,  
11 2015.

12           Section 3. Effective Date. This act shall become law upon approval by the Governor or  
13 upon its becoming law without such approval.




