



A BILL FOR AN ACT

To amend Title 3 of the Kosrae State Code, by amending Section 3.1104 thereof, as amended, to specify the date for the General Election of Kosrae State; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Section 3.1104 of Title 3 of the Kosrae State Code is hereby amended to read  
2 as follows:

3                   “Section 3.1104. Election date & notice. General elections shall be held on the  
4 first Tuesday following the first Monday in November in an even numbered year every four  
5 years; PROVIDED, in the event of a natural disaster or other Acts of God, the effect of which  
6 precludes holding the election of the foregoing date, the Governor may proclaim a later election to  
7 be held within sixty days. Special elections may be held in accordance with law. The  
8 Commission gives public notice in advance of an election as follows:

9                   (1)    General election . . . . . ninety days

10                  (2)    Any other election . . . . . forty days”

11           Section 2. Effective Date. This act shall become law upon approval by the Governor or  
12 upon its becoming law without such approval.


