

A BILL FOR AN ACT

To amend Title 10 of the Kosrae State Code, by amending Section 10.501 in its entirety and renumbering Section 10.502 to Section 10.501 for the purpose of removing the authorization for disbursement of national funds granted to Kosrae State without legislative approval; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Repeal. Section 10.501 of Title 10 of the Kosrae State Code is hereby repealed
2 in its entirety.

3 Section 2. Renumbering. Section 10.502 of Title 10 of the Kosrae State Code is hereby
4 amended by renumbering as follows:

5 “Section 10.501. Advances on Behalf of Third Parties.. There shall be no
6 disbursements of State funds on behalf of third parties without approval by the Legislature
7 except where the original appropriation by the legislature clearly contemplated and expressly or
8 implicitly authorized disbursement of State funds on behalf of the third party.”

9 Section 3. Effective Date. This act shall become law upon approval by the Governor or
10 upon its becoming law without such approval.


