A BILL FOR AN ACT

To further amend Section 10.205 of Title 10 of the Kosrae State Code, as amended by S.L. Nos. 8-17, 8-46, 8-234, 9-15, 9-63, 9-81, 9-140 and 10-66, to expand the use of the Health Care Fund to support the referral program of the State; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this Act is to provide that the Health Care Fund of
2 the Department of Health Services may be used to assist the referral program of Kosrae State.

3 Section 2. Amendment. Section 10.205 of Title 10 of the Kosrae State Code, as
4 amended by S.L. Nos. 8-17, 8-46, 8-234, 9-15, 9-63, 9-81, 9-140 and 10-66 is hereby amended
5 to as follows:

6 “(1) The Revenue Fund contains all monies received by the Government
7 pursuant to a law imposing a tax, duty or tariff, and all other revenues and reimbursements from
8 a fine, fee, license, interest, rent, or Government service, and other Government collection or
9 collections by a government for the Government's benefit except as otherwise required by law.
10 A person who receives monies pursuant to this section transmits the monies within seven days of
11 receipt to the Division of Finance and Budget for deposit in the Revenue Fund except that:

12 ***

13 (g) The Division of Finance and Budget retains in a Health Care Fund
14 all monies collected from or on behalf of patients or clients or the Kosrae Department of the
15 Health Services, including, but not limited to, reimbursements from any program of medical
16 insurance and payments received by the State in connection with off-island referrals. Monies in
17 the Health Care Fund are continually appropriated for expenditures by the Department of Health

1 Services primarily for the purchase of medical and pharmaceutical supplies, for its clinics,
2 dispensaries, programs and patients. The fund may also be used to support the off-island
3 medical referral services of the State and to advance payment of employees' salaries and
4 benefits, when those salaries and benefits have been authorized for reimbursement by the
5 Federated States of Micronesia National Government; provided, however, that the funds received
6 as reimbursement shall be deposited in the Health Care Fund.”


7 Section 3. Effective Date. This act takes effect upon the approval of the Governor or
8 upon its becoming law without such approval.




