#### A BILL FOR AN ACT

To further amend Title 7 of the Kosrae State Code, by amending Section 7.102 thereof and creating a new Chapter 17 to establish the Price Control Commission; and for other purposes.

#### BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1	Section 1. Section 7.102 of Title 7 of the Kosrae State Code, as amended by State Law		
2	Nos. 4-117, 5-56, 5-68, 6-1, 6-158, 7-1, 7-62, 7-91, 8-118, 9-52 and 9-53, is hereby amended to		
3	read as follows:		
4	"Section 7.102. Agencies; enumeration. The agencies are:		
5	(1)	The Broadcast Authority	
6	(2)	The Election Commission	
7	(3)	The Kosrae Island Resource Management Authority	
8	(4)	The Port Authority	
9	(5)	The Parole Board	
10	(6)	The Sports Council	
11	(7)	The Scholarship Board	
12	(8)	The Utility Authority	
13	(9)	The Visitors Bureau	
14	(10)	The Education Advisory Board	
15	(11)	Health Advisory Board	
16	12 (1 <b>3</b> )	The Hausing Authority Price Control Commission"	

1	Section 2. Title 7 of the Kosrae State Code is hereby amended to include a new Chapter		
2	17 to read as follows:		
3	"Chapter 17. Price Control Commission		
4	Section 7.1701. Purpose. Whereas the people of Kosrae rely heavily on imported		
5	goods, such as food, fuel, building materials, and others to supplement daily living, and whereas		
6	the price charged to the ultimate consumer for imported goods often rises, especially in time of		
7	shortage thereby exploiting the public. Now therefore, this new Chapter is created to establish		
8	the Price Control Commission to protect the people of Kosrae from price exploitation.		
9	Section 7.1702. <u>Definitions</u> . The following definitions shall apply in this chapter,		
10	unless the context clearly requires otherwise:		
11	(1) "Commission" means Price Conrol Commission.		
12	(2) "Cost" means the actual cost paid or promised by the seller for the		
13	item itself, exclusive of charges for shipping, handling, interest, warehousing, overhead, rent,		
14	salaries, damage, and loss.		
15	(3) "Item" means any good, personal property or tangible thing brought		
16	into Kosrae from outside the state.		
17	(4) "Price" means the total amount of money or other valuable		
18	consideration exclusive of sale tax paid or promised by the buyer to the seller.		
19	(5) "Sale" means any transfer for money or other valuable consideration in		
20	the regular course of business, weather wholesale or retial.		

1 Section 7.1703. Presumptions. The following presumptions shall apply to the 2 interpretation and enforcement of this chapter: 3 Origin of Items. It is presumed that any item sold in Kosrae is imported until the contrary is proven. The burden of proving that an item is not imported shall be upon the 4 5 seller. 6 Place of sale. It is presumed that any sale of an imported item that is arranged or consummated through or with the assistance of an agent in Kosrae is a sale within 7 Kosrae unless the contrary is proven. The burden of proving a sale outside of Kosrae shall be 8 9 upon the seller or his Kosrae agent. 10 Section 7.1704. Price Control Commission. 11 There is here by established a Price Control Commission in Kosrae to be composed of five members appointed by the Governor with the advice and consent of the 12 Legislature. The members appointed shall be citizens residing in Kosrae State. The membership 13 14 of the Commission shall not include more than one person having a controlling ownership or a 15 manaerial interest in one or more businesses in Kosrae. The Director for the Department of 16 Resources and Economic Affairs shall be an ex-officio member of the Commission, without the 17 right to vote. The term of office of the appointed members of the Commissiono shall 18 (2)19 be two years. Appointments to fill vacancies shall be for the remainder of the unexpired term. 20 At the first meeting and annually thereafter the Commission shall elect a (3)

Chairman from among its appointed members. Meetings shall be held not less than every 60 1 2 days and may be called by the Chairman, three of the appointed members, or the Governor. A 3 quorum of the Commission shall be four appointed members, and the assent of three members present and voting shall be required for all decisions requiring a vote. With prior approval from 4 5 the Governor, the Commission shall adopt regulation and by-laws for its own governnce. 6 Members of the Commission shall be compensated at rates established (4) by the law when actually attending meetings of the Commission; PROVIDED, that if ose 7 8 members who are government employees shall receive their regular salaries while performing 9 functionsd of the Commission. The Department of Resources and Economic Affairs shall offer technical assistance to the Commission and provide records within its possession as requested by 10 the Commission. The Attorney General shall serve as counsel for the Commission. The 11 12 Department of Resources and Economic Affairs shall serve as secretariate for the Commission. 13 Section 7.1705. Duties and Functions of the Board. The Board's duties and functions shall: 14 Inspection and examination of the cost of items to seller and the price to 15 16 buyers in Kosrae; Reports to Chief of Police or the Attorney General Office of non-17 (2)18 compliance; 19 Maintain records and files of the cost of items imported into the state 20 and advise the public of the maximum price chargeable by sellers of items;

1	(4) Develop information concerning the pricing practices of sellers in
2	Kosrae;
3	(5) Consult with and advice merchants and sellers of imported items
4	concerning this chapter and its implementation;
5	(6) Promulgate regulations, subject to the approval of the Governor, for the
6	implementation and enforcement of this chapter; and
7	(7) Ensure compliance of all sellers of imported items in the state with this
8	chapter and all rules and regulations issued pursuant hereto.
9	Section 3. Effective Date. This act shall become law upon approval by the Governor or
10	upon its becoming law without such approval.
11
