

A BILL FOR ACT

To amend State Law No. 10-134 to de-appropriate \$5,000.00 included in the Attorney General's personnel budget for fiscal year ending September 30, 2015; and for other purposes.

1           Section 1. Purpose. The purpose of this act is to de-appropriate \$5,000.00 from the  
2 Attorney General budgeted for personnel under the revenue fund for fiscal year ending  
3 September 30, 2015.

4           Section 2. Amendment. State Law No. 10-134 at title, line one, section 1 and 2,  
5 subsection (16) are hereby amended to read as follows:

6                   “To appropriate the sum of \$9,771,867 from the Amended Compact Fund; the sum  
7 of \$1,824,260 from the State Revenue Fund; the sum of \$1,015,642 from the United States Grant  
8 Fund; and the sum of \$183,000 from the Foreign Assistance Fund of the Kosrae State Treasury  
9 for the fiscal year ending September 30, 2015, for the purpose of funding the operations of all  
10 branches of the Kosrae State Government, its agencies, and various programs; and for other  
11 purposes.

12                   “Section 1. Appropriation. Operation of the Executive. The sum of \$6,230,103, or  
13 so much thereof as may be necessary, is appropriated from the Amended Compact Fund; the sum  
14 of \$885,936, or so much thereof as may be necessary, is appropriated from the State Revenue  
15 Fund; the sum of \$959,431 or so much thereof as may be necessary, is appropriated from the  
16 United States Grant Fund; and the sum of \$25,000 or so much thereof as may be necessary, is  
17 appropriated from the Foreign Assistance Fund for the operation of the Executive Branch for the  
18 fiscal year ending September 30, 2015.

1 Section 2. Apportionment. Operation of the Executive. The sums appropriated by  
 2 Section 1 of this act are apportioned as follows:





4           Section 2. Amendment. State Law No. 10-134 at title, line one, section 1 and 2,  
5 subsection (16) are hereby amended to read as follows:

6                   “To appropriate the sum of \$9,771,867 from the Amended Compact Fund; the sum  
7 of \$1,824,260 from the State Revenue Fund; the sum of \$1,015,642 from the United States Grant
