

A BILL FOR AN ACT

To appropriate the sum of \$60,856 from the Local Revenue Fund of the Kosrae State Treasury for the purpose of funding the former Micronesia Petroleum Corporation (MPC) Loan Repayment Program for the fiscal year ending September 30, 2012; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$60,856 is hereby appropriated from the Local
2 Revenue Fund of the Kosrae State Treasury for the purpose of funding the former Micronesian
3 Petroleum Corporation (MPC) Loan Repayment Program for the fiscal year ending September
4 30, 2012.

5 Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,
6 administered and accounted for in accordance with applicable laws. The allottee of the fund
7 appropriated by this act shall be the Governor of the State of Kosrae. The allottee shall be
8 responsible for ensuring that these funds, or so much thereof as may be necessary, are used
9 solely for the purpose specified in this act and that no obligations are incurred in excess of the
10 sum appropriated. The authority of the allottee to obligate funds appropriated by this act shall
11 lapse on September 30, 2012.

12 Section 3. Effective Date. This act takes effect upon the approval of the Governor or
13 upon its becoming law without such approval.
