A BILL FOR AN ACT

To appropriate the sum of \$1,000 from the Revenue Fund of the Kosrae State Treasury to provide funding for the 2012 July 20 celebration in the Utwe Municipality; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

Section 1. Appropriation. The sum of \$1,000 is hereby appropriate from the Revenue
Fund of the Kosrae State Treasury to provide funding for the 2012 July 20 celebration in the
Utwe Municipality.

Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,
administered and accounted for in accordance with applicable laws. The allottee of the ind
appropriated by this act shall be the Governor of the State of Kosrae. The allottee shall be
responsible for ensuring that these funds, or so much thereof as may be necessary, are used

responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act and that no obligations are incurred in excess of the sum appropriated. The authority of the allottee to obligate funds appropriated by this act shall lapse on September 30, 2012.

Section 3. <u>Effective Date</u>. This act takes effect upon the approval of the Governor or upon its becoming law without such approval.
