



A BILL FOR AN ACT

To appropriate the sum of \$3,000 from the Revenue Fund of the Kosrae State Treasury to provide funding for the Kosrae State Fair scheduled for September 20-21, 2012; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$3,000 is hereby appropriated from the Revenue
2 Fund of the Kosrae State Treasury to provide awards to the Kosrae State Fair.

3 Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,
4 administered and accounted for in accordance with applicable laws. The allottee of the funds
5 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring
6 that these funds, or so much thereof as may be necessary, are used for the purpose for which are
7 appropriated and that no obligations are incurred in excess of the sum appropriated. The
8 authority of the allottee to obligate funds appropriated by this act shall lapse on September 30,
9 2012.

10 Section 3. Effective Date. This act takes effect upon the approval of the Governor or
11 upon its becoming law without such approval.
