



A BILL FOR AN ACT

To amend State Law No. 10-40 at Section 1 to provide supplemental funding for the operation of the USDA Rural Development Office in Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Amendment. Section 1 of Kosrae State Law No. 10-40 is amended to read as
2 follows:

3 “Section 1. Appropriation. The sum of \$6,900 is hereby appropriated from the
4 Local Revenue Fund of the Kosrae State Treasury for the purpose of funding the salaries of the
5 gratuitous employee working with the USDA Rural Development Office in the State of Kosrae
6 for the fourth quarter of the fiscal year 2012.”

7 Section 2. Effective Date. This act takes effect upon the approval of the Governor or
8 upon its becoming law without such approval.


